1. INTRODUCTION

The Statute constitutes the reference point of the entire Study Group organisation, identifying the Bodies, powers and respective functions and tasks.

Locations

OSHO carries out its activities in several locations within Germany (and beyond), the management of which has progressively grown over the years.

2. THE ORGANISATIONAL STRUCTURE

Consistent with the Statute, OSHO adopts a democratic model inspired by the principle of equality of all members. To this end, the administrative secretary of the OSHO is located in Strümpellstraße 42; 04289 Leipzig, Germany (info@osho-studiengruppe.de). The OSHO Fortbildungsakademie (OSHO Academy of Education; OSHO Services GmbH) is also located in Leipzig, Germany (info@osho-services.de; www.osho-services.de).

The OSHO is organized as follows:

- a) The general assembly
- b) Board of Directors
- c) Steering Committee
- d) Financial auditor
- e) Arbitration Committee

At all levels, the members of the OSHO jointly ensure competence and a balance between the genders in compliance with current legislation on gender balance.

Membership is open for every physician and scientific worker who are involved in the field of hematology and oncology irrespective of the place of work (University, community based, or outpatient clinic), area (urban or rural), age, or gender. After submitting an application, all members will be informed per e-mail) and if no objections exist, membership will be granted. The OSHO organizes two scientific meetings per year over two days each (the spring and autumn meetings) where the scientific projects and trials are presented and discussed. The spring meeting has a traditional place in the middle of Germany (Woerlitz) and the autumn OSHO meeting rotates among the different cities where the members work (the location and the organizers are chosen from the members in the general assembly irrespective of gender). Additionally, the OSHO Academy of Education organizes a series of 8 educational blocks over two years (version 1 from 2019-2021 and version 2 from 2021-2023)

Steering Committee

The steering committee is composed of the Board of Directors, representatives from Universities, community based hospitals, and outpatient clinics. The members of the steering committee are nominated and elected by the members of the OSHO at the general assembly every two years.

The nomination and election are open for each OSHO member.

The steering committee is the collegial body prepared for the scientific management of the Study Group and preparing the scientific agenda of the biannual OSHO meetings and the educational program of the OSHO Academy of Education. The steering committee meets four times per year and at the biannual scientific meetings of the OSHO.

3. INTERNAL CONTEXT

OSHO is a Scientific Association which prosecutes exclusively and directly charitable purposes. The OSHO members, the Board of Directors, the Steering Committee, and the members of the Arbitration Committee act voluntarily and without financial compensation.

The OSHO e.V. workforce survey carried out at 14/03/2023 showed the following composition:

FIGURE 2. OSHO MEMBERS 2013




FIGURE 3. MEMBERS OF THE STEERING COMMITTEE





FIGURE 4. PRINCIPAL INVESTIGATORS OF 21 OSHO TRIALS (2010-2023)





Figure 6. Participant & speaker gender

4. AREAS OF ACTION

The enhancement of gender equality is a fundamental pillar of the European Union (EU), which has been integrated into the European Commission's strategy for gender equality for the period 2020-2025. The EU provides a regulatory framework on gender equality, based on binding directives that apply not only to the labour market but also to the research sector.

The peculiarities of this sector have promoted the research and definition of Targeted actions that have found their realisation within the European Research Area (ERA) and its main funding instrument in Horizon Europe. Both contribute synergistically to fostering collaboration and enhancing the impact of research and innovation in the development, support, and implementation of the same EU policies. In this context, gender equality is an indispensable cross-cutting priority in the European Commission's strategy, as it aims at ensuring an innovative, competitive, and flourishing European economy. The first pages of the document A Union of Equality: Gender Equality strategy 2020-2025 recites:

"The promotion of equality between women and men is a task for the European Union, in all its activities, required by the Treaties. Gender equality is a core value of the EU, a fundamental right and key principle of the European Pillar of Social Rights. It is a reflection of who we are. It is also an essential condition for an innovative, competitive, and thriving European."

To realise this project, the European Commission has adopted Gender Mainstreaming as the ideal method for promoting equal opportunities for men and women. The pivotal thought of Gender Mainstreaming is that no programming initiative can be considered gender neutral, given the influence that gender has as a social construct in influencing the behaviour of citizens. The origins of this approach are rooted in the desire to provide a more faithful representation of society, emphasising the differences in behaviours between men and women. Supporting gender neutrality implies adopting a model characterised by "standard" individuals who not only do not exist in reality, but who in the political and social imagination are male, middle-aged without specific needs and requirements (disability, illness, need for aids or support for treatment). The aim of gender mainstreaming is to promote the development of policies that consider these differences, as well as gender differences, in order to foster inclusiveness and to guide institutional and social structures and organisations towards greater equity for men and women.

The realisation of this design requires the identification of clear and concrete

objectives and targets, which in turn make it possible to set measurable indicators, so as to facilitate the transition from the theoretical to the practical dimension. The Gender Equality Plans (GEPs) are documents that allow its fulfilment, since they allow to define not only the legal, organisational, economic, and social framework, but also the operational conditions to implement gender equality. These are the strategic, operational, and tailor-made tools necessary to bring systematic institutional change through the identification of strategies for the development of human resources, institutional governance, the allocation of research funding, institutional leadership, and decision-making and research programmes.

The development of effective GEPs should encourage self-reflection by staff and the institutions' decision-making bodies, while supporting a continuous review process involving the whole organisation. For this reason, in the development of the following GEP, respect and awareness of the steps that constitute its life cycle were followed:

- An audit phase. Elements of this phase include the collection of gender data And the review of relevant national and regional laws, regulations, or funding requirements.
- A planning phase. The objectives of the EDM are set out together with a table showing the actions and measures to be taken, as well as the identification of specific resources for its implementation.
- An implementation phase, in which the activity roadmap is implemented, including the creation of working groups to develop and implement new policies and procedures.
- A monitoring and evaluation phase, in which the review of the plan and the progress with respect to its aims and objectives are regularly and annually evaluated.

In line with the main objectives supported by the European Commission to Combat stereotypes and bridge the gender gap in the labour market, the Document addresses the following areas:

- Work-life balance and organisational culture
- Gender balance in top positions and in decision-making bodies
- Gender equality in recruitment and career progression
- Gender mainstreaming in research
- Contrasting gender-based violence

4.1 Promoting balance between private life and working life and the culture of the organisation

The main objective of this macro-area is to identify the actions to be taken to promote the reconciliation of work and private life. In this regard, OSHO is A STUDY GROUP with most of its members participating voluntarily and free of compensation. The OSHO has limited employers as described previously.

Nevertheless, in the last years, the OSHO adopted an internal policy, designed to regulate agile work; "in order to increase competitiveness and facilitate the reconciliation of life and work time as a method of execution of the subordinate employment relationship established by agreement between the parties, also with forms of organisation by phases, cycles and objectives and without precise constraints of time or place of work, with the possible use of technological tools".

We therefore follow the objective of increasing competitiveness through work by phases, cycles, and objectives, which is essential for working without constraints of time and space. Without time constraints – but in compliance with the time limits established by law - because the performance is aimed at a result but without space constraints, because in the face of a broader trust and responsibility of the employee relying on his or her ability to regulate the phases of work according to a result, there must be a renunciation by the employer to "visually" control the collaborator. From a psychological point of view, this means the liberation from the axiom: attendance = work, with the consequent abandoning of control over the performance in favour of a verification of the results expected from the performance.

Trust constitutes the fundamental prerequisite of the Smart working organisational structure of work!!

The OSHO Board of Directors has been pursuing the objectives of Agile Work with both the secretary and the CEO of the OSHO Academy of Education. Customised individual agreements have been signed in order to regulate workn a timely manner. Access to this mode of work, allows staff to reconcile working time with private time, in order to meet family and personal needs.

4.5 Contrasting gender-based violence

Gender-based violence, harassment and bullying are complex situations that can in turn lead to isolation and discrimination of victims. These situations represent critical issues that can occur in different circumstances and environments, including research organisations and research funding organisations. OSHO recognises and guarantees equal opportunities, organisational well-being, the protection from bullying and sexual harassment. In 2022, the OSHO established an Arbitration Committee and integrated the Committee in its Statute.
